## Conditions for Social Additional Support

Those who are 67 years of age or older and have permanent residence and legal domicile in Iceland can apply for additional support payments. Foreign nationals must have a permanent residence permit in Iceland or the right of permanent residence. The conditions of having permanent residence permit or the right of permanent residence, may be exempted under special circumstances. The applicant must have applied for and taken out in full all the rights he may have acquired already. The applicant must appear in person to confirm his stay in this country, at TR service centre at Hlíðarsmári 11 or at its agencies all over the country.

All his estimated income must be stated for the period which entitlements have been applied for. Tryggingastofnun will gather the necessary information that is required to evaluate the applicant's case before being processed., e.g. from the Directorate of Immigration, municipal authorities and pension funds. If needed, TR will demand further information from the applicant.

## Income estimate 2020

The income estimate is the responsibility of the applicants or payment recipients.

It is appropriate, and obligatory, for applicants and payment recipients to take part in the processing of their cases, this includes attending interviews and providing TR with the information needed to make a decision regarding their benefit entitlements and the amount and payment of benefits. Furthermore, it is obligatory to report changes in income or other circumstances that could affect the applicants right to additional support and its payments.

Tryggingastofnun shall regularly verify whether benefits, payments and the information on which its decisions are based are correct. For the purpose of monitoring, TR may call for such information and may defer the decision and the payment of benefit, until the situation is rectified, in accordance with the Act on social additional support for the elderly no. 74/2020.
